

## KanCare Health Homes Forum

Implementation of health homes in KanCare will begin January 2014, for persons with serious mental illness. Additional target groups will follow closely, including individuals with chronic conditions such as diabetes. The State anticipates that some health home services would be provided by the MCOs and some by the Health Home Partner, which can be one of a variety of different types of providers. Some services may be jointly provided by the two. Together, the MCO and Health Home Partner will make up the health home. The State is in the process of defining the six core services, provider standards and qualifications, quality measures and other components of the Medicaid State Plan Amendment that must be submitted to CMS.

This forum is intended to solicit input on the Kansas health homes proposal and bring participants up-to-date on the development of health homes within KanCare.
