Welcome - Sarah Fertig Review and Approval of Minutes from Council meeting June 9, 2020

Sarah Fertig asked if the Advisory Council had any changes to the proposed agenda and there were none. Sarah Fertig asked if there was any discussion on the previous meeting's minutes. Michael Kennedy moved the June 9, 2020 minutes be approved as written. Mark Hinde seconded the motion and the minutes were approved by the Council.

Old Business - KanCare Advisory Council

Define the capable person policy in regard to the care of our disabled kids and adults in need of care per their personal care plans – Ed Nicholas

Amy Penrod will provide resources on the requirements for the capable person policy at the next meeting. Topic will remain on old business.

Update on staffing issues for those in need of Long-Term Care – Ed Nicholas

Ed Nicholas and Amy Penrod had a discussion during the meeting. This topic will be removed from old business.

Update on progress of the steps being done on the different agencies that can help waiver consumers obtain the hours of care that have been allotted via their personal centered care plans for Nursing and or Personal Care Attendants (Self-directed or agency directed) – Ed Nicholas Sarah Fertig stated this issue is being studied and addressed on the TA waiver side. This topic will be removed from old business.

Aetna Better Health still not paying anything that requires a CLIA# - Dr. Rebecca Reddy Dr Rebecca Reddy stated this issue has been resolved. This topic will be removed from old business.

HEDIS reports not fair on vaccine refusal/hesitancy (requested by Sue Ann Jantz, Cottonwood Pediatrics) – Chris Swartz

Chris Swartz stated KDHE doesn't have a say on what is counted or not counted for the measures. This report is completed by the federal government. This topic will be removed from old business.

New Business – KanCare Advisory Council

Concerns with delays in credentialing of providers for KanCare – Walt Hill

Dr Rebecca Reddy questioned MCO's what their expectations are for credentialing in midst of the pandemic. The MCO's have 90 days to complete the credentialing and receive a signed contract from the provider. Sunflower stated providers and clinics are having a hard time with board certification for new residency graduates, which is delaying the credentialing by more than a month.

Chris Swartz advised a work group is being formed to identify issues and have solutions in place by October.

Can the MCO's share with us an estimate of their cost paid out in patient care services (outpatient and inpatient or other) to date since the start of the pandemic, compared to the same time period last year? – Dr. Rebecca Reddy

Sarah Fertig stated two documents were emailed prior to the meeting with this information. Documents reviewed during meeting.

Can the MCO's give us information about their pediatric patient enrollment broken down by age? Age 0-3yrs, 4-6yrs, 7-12, and 13-17yrs? And does the state have information about the number of applications for KanCare that are being processed in the last 3-4 months compared to last year? – Dr. Rebecca Reddy

Sarah Fertig stated one document was emailed prior to the meeting with this information. Document reviewed during meeting.

What have our MCO's done to be ready for the change in E and M service changes for outpatient services which will be in effect on January 1, 2021 https://www.ama-assn.org/system/files/2019-06/cpt-office-prolonged-sys-code-changes.pdf - Dr Rebecca Reddy

Lisa Baird - Aetna Better Health, Carrie Kimes - United Health Care, and Stephanie Rasmussen – Sunflower Health Care stated staff is receiving training on the new rules and processes.

Regarding new CPT codes related to outpatient care for COVID related concerns, will the new codes 99072 (charge for PPE and additional time/resources spent related to COVID patients) and 87426 (outpatient rapid COVID antigen test including the SOPHIA and BD code 87426 being recognized to the KMAP system and assigned payment of #38.45, which does not cover the cost of these tests. https://www.ama-assn.org/practice-management/cpt/covid-19-coding-and-guidance - Dr Rebecca Reddy

Dr Norman and Sarah Fertig will address this concern with the DHCF clinical team. Topic will remain on old business.

HCBS staffing for people and COVID PPE and testing. Some of the feedback I have received is that clients are afraid to have help in their home unless people are tested but they can't be tested unless they are symptomatic, and the tests aren't affordable. Also, the agencies aren't providing PPE – Njeri Shomari

Janis Deboer stated KDADS has requested \$12 million dollars funding for community-based providers. At this time, Janis is unsure how many providers will accept the funding. Topic to remain on old business.

KDHE Update – Sarah Fertig, Medicaid Director, Kansas Department of Health and Environment and Chris Swartz, Director of Operations/COO, Deputy Medicaid Director, Kansas Department of Health and Environment and Dr Lee Norman, Secretary, Kansas Department Health and Environment Sarah Fertig provided an update of the KDHE presentation from the Bob Bethell Joint Committee meeting. Sarah reviewed the KanCare Executive Summary. She also spoke of the agency's participation in the Special Committee on Mental Health Modernization and Reform. Chris Swartz serves as a subject matter expert for the Programming System and Processes and Sarah serves on the committee for Finance and Sustainability. Sarah spoke on Telehealth and stated no changes have been made to the newly open codes. KDHE is currently down 3,000 applications per month due to Kansas not being an expansion state. We are currently delaying KanCare annual renewals and termination of eligibility during COVID.

Chris Swartz stated she is very happy to have Sarah on board and has caught up quickly with the complexity of the program. Chris provided an update on the current renewal processes for KanCare members. KDHE currently has only a handful of applications over 45 days. The Clearing House RFP bid awarded on August 5, 2020 to Conduit will begin work January 2021. Conduit will process family medical applications.
