Welcome – Chairman Larry Martin

Review and Approval of Minutes from Council meeting, August 5, 2019

Chairman Larry Martin asked if the Advisory Council had any changes to the proposed agenda and there were none. Chairman Larry Martin asked if there was any discussion on the previous meeting's minutes. Dr Kennedy moved the August 6, 2019 minutes be approved as written. Ed Nicholas seconded the motion and the minutes were approved by the Council.

Old Business – KanCare Advisory Council

Update on expected time for credentialing by each MCO for individual providers – Walt Hill Aetna Better Health of Kansas - David Livingston: Credentialing is more than 90 days to complete. The paperwork for credentialing delayed, providers denied as non-contracted in error, data is discrepant, cannot determine accuracy of the report nor network adequacy.

Sunflower State Health Plan - Miranda Steele: Credentialing turn-around time is 45 days. **United Healthcare Community Plan - Jeff Stafford**: Credentialing is right at 30 days.

Update on staffing issues for those in need of Long-Term Care – Ed Nicholas

Ed Nicholas inquired if the legislature approves the funding; is the State prepared for post days. Topic will remain on old business for an update.

New Business – KanCare Advisory Council

Current and projected shortage of direct care workers (Direct Support Professionals) in Kansas – Allen Schmidt

Chairman Larry Martin provided a brief update. Significant numbers in short fall on health care workers, particularly those involved in long term care. No plan of action for the community survey. A letter was sent to the Governor to propose an action comity to address nursing shortages. At this time, no feedback given on the proposed plan. Topic will remain on old business for an update.

Remedial actions against Aetna Better Health and how this has improved – Lora Key

Adam Proffitt emphasized Aetna placed on noncompliance and working through the Corrective Action Plan (CAP) approved September 1, 2019. Aetna has closed numerous action items on the CAP and 5-7 meetings occur each week between Operational and Leadership Team.

David Livingston provided an update. In late August Aetna brought in Senior Leadership replacing the others. Adding 33% additional individuals in the provider area. Significant progress has been accomplished on the CAP.

Update on State's assessment of Aetna Better Health performance – Larry Martin Discussion on agenda topic listed above.

Update on progress of the steps being done on the different agencies that can help waiver consumers obtain the hours of care that have been allotted via their personal centered care plans for Nursing and or Personal Care Attendants (Self-directed or agency directed) – Ed Nicholas Discussion was held. Ed Nicholas expressed concern in shortage of nursing for MTI and TA. Topic will remain on old business for an update.

Define the capable person policy in regard to the care of our disabled kids and adults in need of care per their personal care plans – Ed Nicholas

Ed Nicholas expressed concern for families with the changes made in 2016 on the capable person policy. Secretary Howard from KDADS will follow up on this discussion and provide an update at the next meeting. Topic will remain on old business.

KDHE Update – Adam Proffitt, Medicaid Director, Kansas Department of Health and Environment and Chris Swartz, Director of Operations/COO, Deputy Medicaid Director, Kansas Department of Health and Environment

Adam emphasized on Bethell Oversight Committee. The State presents to the committee from a power point presentation and reviews the Executive Summary providing an update on the Medicaid program. The State has provided testimony on Medicaid Expansion in front of the legislature. A final evaluation of the KanCare demonstration was approved with CMS and posted to the KanCare website.

KDADS Update – Janis DeBoer, Deputy Secretary, Kansas Department of Aging and Disability Services and Amy Penrod, Commissioner, Community Services and Programs Commission, Kansas Department for Aging and Disability Services

Increased protected income level to \$1,177 a month. Children will be added to the Brain Injury waiver very soon. Individuals who have had strokes will also be added to the waiver.
