RE: Summary of Changes (SOC) for Medical KEESM Revision #8	Program(s): Elderly & Disabled Medical

The purpose of this document is to provide the detailed Summary of Changes for implementing revisions to the Medical KEESM manual effective May 1, 2018. In addition to this document, KDHE Policy Memo 2018-04-01 has been issued. Manual changes are outlined below.

- 2675.4** **Benefits and Levels of Subsidy** – This section has been updated to reflect ICF-IID as the correct facility type. This is a minor wording change that has no impact on the policy.
- 5720.1** **Services Impacted by Transfer of Property** – This section has been updated to reflect ICF-IID as the correct facility type. This is a minor wording change that has no impact on the policy.
- 7121** **Intermittent Income and Deductions** – This section has been updated to remove references to the Interim Report form as this form is not used for Medical programs.
- 8112.1** **Adult Care Homes (ACH)** – This section has been updated to reflect ICF-IID as the correct facility type. This is a minor wording change that has no impact on the policy.
- 8112.2** **State Facilities Certified as ICF-IID** – This section has been updated to reflect ICF-IID as the correct facility type. This is a minor wording change that has no impact on the policy.
- 8114** **CARE Assessment Process and Eligibility** – This section has been revised to capture updated language included in the KDADS Level I CARE Manual. The reference to a ‘provisional admission’ was changed to the term ‘special admission’.
- 8184.1** **The MS-2126** – This section has been updated to reflect ICF-IID as the correct facility type. This is a minor wording change that has no impact on the policy.

- 8212** **Physical Disabled Waiver (HCBS/PD)** – This section has been updated to reflect ICF-IID as the correct facility type. This is a minor wording change that has no impact on the policy.
- 8213** **Intellectual and Developmental Disability Waiver (HCBS/I/DD)** - This section has been updated to reflect ICF-IID as the correct facility type. This is a minor wording change that has no impact on the policy.
