CSSP Online Application Questions Eligibility Processing Job Aid

This Job Aid is intended to provide instruction on the required elements of the online application. The system requires an answer for a few application questions; however, the customer has the ability to submit an application with lots of missing pieces of information. This Job Aid identifies when an answer left blank is acceptable and when additional follow-up is required.

Note:

- Mandatory verification policies still apply. Obtain verification as required in KEESM 1322 or KFMAM 1325
- When a Leading Question has been answered Yes then the Follow-up Questions will always be required. For
 example, if a customer indicates they are self-employed, then it is necessary to obtain answers to all of the selfemployment Follow-up questions.
- These instructions are intended as a guide and should not replace the prudent person principle.

People: This section is in reference to the applicant and all household members

What is the living situation of this person	Assume 'In the home' if left blank
How are you related to this person?	Contact applicant to obtain answer if not otherwise known

Property: This section includes information about the Household's resources.

- Assume No, if the questions are left blank.
- If answer is Yes, the Follow-up questions are required.

Other Income: This section applies to all unearned income questions

- Assume No, if the questions are left blank.
- If answer is Yes, the Follow-up questions are required.

Job-Wages: This section applies to all Earned income questions

- If answer is Yes, the Follow-up questions are required.
- If answer is Yes for 'Other Health Insurance' ensure that health insurance details are provided in the 'Other' section of the application.
