- **Before the member's Individual Service Plan is submitted to the MCO, the CSC is required to confirm that the chosen provider(s) can serve the referral.**
 - If this requires longer to locate a provider than the ISP submission timeline, please notify the MCO and the STEPS Program Manger so more time can be allowed, **OR**
 - submit the ISP with the provider listed as TBD and a revised ISP can be submitted to add a provider later.
- CSCs cannot direct members to the agency for which they work or are affiliated with for services (limited exceptions may apply on a case-by-case basis).
- If a service does not apply to a member or if a member closes out of a service, please check the N/A box in the service type header and submit this form with the revised Service Plan.
 - The N/A box will only appear in the first service type header box when the section spans onto the next page.
- If a service will be paid thru another source (such as VR or a CIL), please check the Paid thru another source box.
 - On the Service Plan, do NOT check the box for the service being paid thru another source. Leave the Amount blank. Indicate the payor source as the name of the provider.
